3. Purpose and legal basis on which we process personal data

3.1 Call Facebook fanpage

We use the technical platform and services of Facebook Ireland Ltd, 4 Grand Canal Square Grand Canal Harbour, Dublin 2, Ireland for the information service offered here. For this purpose, we have entered into an agreement with the provider regarding the joint processing of your data, which forms the basis of the contractual rights of use by us.

We would like to point out that you use our Facebook fanpage and its functions on your own responsibility. This applies in particular to the use of the interactive functions (e.g. networking, sharing, rating). Alternatively, you can also access the information offered via this page on our website at https://www.leukhardt.de.

When you visit our Facebook page, Facebook collects, among other things, your IP address and other information that is also present in the form of cookies on your PC. This information is used to provide us, as operators of the Facebook pages, with statistical information about the use of the Facebook page. The contents of these evaluations are exclusively anonymous. We can in no case establish a connection to your person.

The data collected about you in this context is processed by Facebook Ltd. and may be transferred to countries outside the European Union. Facebook describes in general terms what information it receives and how it is used in its data usage guidelines. In what way Facebook uses the data from visits to Facebook pages for its own purposes, to what extent activities on the Facebook page are assigned to individual users, how long Facebook stores this data and whether data from a visit to the Facebook page is passed on to third parties, is not conclusively and clearly stated by Facebook. We do not know anything about this.

When you access a Facebook page, the IP address assigned to your end device is transmitted to Facebook. According to Facebook, this IP address is anonymized (for "German" IP addresses). Facebook also stores information about the end devices of its users (e.g., as part of the "login notification" function); this may allow Facebook to assign IP addresses to individual users.

If you are currently logged in to Facebook as a user, a cookie with your Facebook ID is stored on your end device. This enables Facebook to track that you have visited this page and how you have used it. This also applies to all other Facebook pages. Via Facebook buttons embedded in websites, it is possible for Facebook to record your visits to these website pages and assign them to your Facebook profile. Based on this data, content or advertising can be offered tailored to you. If you want to avoid this, you should log out of Facebook or deactivate the "stay logged in" function, delete the cookies present on your device and close your browser and then restart it. In this way, Facebook information through which you can be directly identified will be deleted. This allows you to use our Facebook page without revealing your Facebook identifier. When you access interactive features of the page (like, comment, share, message, etc.), a Facebook login screen will appear. After any login, you will again be recognizable to Facebook as a specific user.

We, as the provider of the information service, do not collect and process any data from your use of our service beyond this.

The legal basis for processing your data is our legitimate interest according to Art. 6 para.1 lit.f GDPR. The purpose is the provision of information and public relations.

4. Who will get to see your data?

Personal data that you publish as part of the use of interactive functions (e.g. commenting, sharing, rating) are openly visible to visitors of the corresponding platforms on the Internet. Beyond that, we do not transmit or otherwise disclose any personal data to third parties.

5. Your data protection rights

We have defined processes within our company so that you can exercise your rights with us. You have a right to,

- revoke your consent at any time with effect for the future (Art.7 para. 3 GDPR).



- to receive information (Art.15 GDPR) about your data stored by us.
- that incorrect data about you will be corrected by us (Art.16 GDPR).
- that we delete data about you that is no longer required (Art.17 GDPR).
- that under certain conditions the processing of your data is restricted (Art.18 GDPR). This may be the case, for example, if deletion is not possible, but the data may not be processed further.
- That your data is transferable (Art. 20 GDPR). This right applies in particular if you have given your consent to the processing of your data or if the processing of the data is necessary to fulfill a contract. The right to data portability does not exist insofar as your data is not processed using automated procedures.
- to object to the further processing of your personal data in a special situation (Art. 21 GDPR), insofar as the processing is based on the legitimate interest (Art.6 para.1 lit.f GDPR) as well as in the case of profiling based on this. You may also object at any time if the data is used for direct marketing purposes (Art. 21 (2) GDPR).
- to complain to a supervisory authority (Art. 77 GDPR) if you are of the opinion that the processing of your data violates the legal requirements. The supervisory authority responsible for us is:
